

## Cornerstone Christian School - Tuition Assistance Plan (TAP) Application

We are so glad you would like to partner with us in raising your child(ren) with a Christian world view.

We have looked to other assistance programs to gauge financial assistance needs. For example, families are eligible for Wyoming Kid Care when their income is less than 200% of the Federal Poverty Guidelines. Families are eligible for Free and Reduced Price Meals at school if their income is 130% or less, or 185% or less, respectively. Income is compared with household size.

The following are a few things to remember regarding our Tuition Assistance Plan:

1. You must re-apply each year of a Tuition Assistance Plan.
2. The application for the first round of consideration must be received by July 1st.
3. If you mail your application to CCS, make it ATTN: TAP's
4. Tuition assistance is not credited to your account until you pay your portion of tuition.

Along with this completed application, please attach a copy of your most recent paystub showing a year to date income amount, and a copy of your most recent Federal Income Tax return 1040 pages 1 and 2.
